**IMPORTANT:** Sarasota County rebates apply only to costs incurred for production or post-production activities that take place in Sarasota County or its municipalities and that are performed by businesses located in Sarasota County or its municipalities or by individuals permanently residing\* in Sarasota County or its municipalities.

Eligible Expenditures are subject to the following conditions:

- Availability of funds.
- Services performed on behalf of the Applicant by non-residents of Sarasota County or businesses not located within Sarasota County are not reimbursable.
- Re-billed goods or services provided by Sarasota County vendor(s) from vendors or suppliers located outside of Sarasota County are not reimbursable.
- Expenditures which have been reimbursed from other sources are NOT qualified expenditures.
- Rebate for lodging expenditures is limited to facilities that remit Tourist Development Tax to Sarasota County.

Subject to the individual project cap, Sarasota County government fees and charges related to production and post-production activities are eligible for a rebate of up to 100%. The rebate for all other eligible expenditures is up to 20%. All rebates are subject to fund availability and are processed on a "first come-first served" basis.
